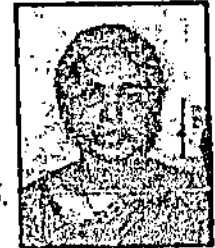

Title: IJPE 745.17: Vibration Analysis of Shaft Misalignment and Diagnosis Method of Structure Faults for Rotating Machinery

Abstract: In this paper, two kinds of dynamic models for shaft misalignment of rotating machinery are proposed for vibration analysis and diagnosis of the shaft misalignment state. In order to obtain the solution of the dynamic models and clarify the vibration signal features measured in the shaft misalignment state, the calculation method of vibration forces caused by misalignments is also shown. The results of computer simulation and experiment using the same rotating machine are shown to verify the efficiency of the dynamic analysis method proposed in this paper. Finally, the method for distinguishing structure faults of rotating machines (shaft misalignment state, unbalance state and looseness state) is discussed by using symptom parameters and spectra of the vibration signal measured in these states.



(6) Matters not expressly stipulated in this Agreement shall follow and conform to the laws and regulations of the Labor Standards Act of the Republic of Korea.

Article 3: C's workplace and duties

(1) C shall work at the workplace designated by B.

(2) As a Post-Doc researcher, the primary duties of C are researching, conducting experiments, assisting students with graduate assignments and participating in activities concerning Planning and Operation of BK21 PLUS Center for Advanced Chemical Technology, and B will assign the duties in detail and in specific to C. C must carry out his/her duties under B's direction.

(3) C's workplace and duties may be adjusted at B's discretion.

제 4 조(보수)

Article 4: Remuneration

(1) The remuneration of C shall be paid from the budget of BK21 PLUS Center for Advanced Chemical Technology.

(2) C shall be paid an annual before-tax income of 27,696,000 KW, in twelve monthly installments of 2,308,000 KW. Also, C shall qualify for his/her severance pay at the end of the one-full year contract period (365days). Payment will be made in accordance with the regulations of severance pay of the Republic of Korea.

(3) The contracted salary in the clause (2) includes C's share of the premiums for the National Health Insurance Plan, the National Pension Plan and Employment Insurance if applicable. The regular pay day is the 20th of each month unless the day falls on a Saturday, Sunday or a Korean national holiday, in which case the salary will be paid on the nearest business day very before the payday.

(4) In the event that the period of actual working days of C is less than one month, the payment for the period shall be made on the basis of the actual working days.

Article 5: Obligations of the Parties

(1) B shall withhold the premiums and taxes from the monthly salary of C in accordance with the regulations concerning the premiums and taxes.

(2) Unless authorized by A, paid off-campus teaching or research activities are not

permitted during the contract period.

(3) C shall devote himself/herself in his/her duties stipulated in Article 3.

(4) C shall follow the rules and policies of PNU including the PNU Researchers Regulations and the regulations of BK21 PLUS Center for Advanced Chemical Technology.

(5) C shall keep confidential the information which he/she becomes aware of in the course of carrying out his/her duties, not only during his/her tenure but also after his/her termination.

Article 6: Termination of this Agreement

A may terminate this agreement upon B's request if C's conduct falls under any of the following clauses:

- (1) Where C cannot perform C's duties due to physical or mental disorders
- (2) Where any of C's documents and research achievements turns out to be fraud
- (3) Where C refuses to obey the orders of B or his/her supervisors without any valid reasons, where C neglects the responsibilities imposed upon him/her by B, or
- (4) Where C violates any of those stipulated apparently in this agreement

Should C's conduct fall under the above clauses pursuant to this Article 6, A shall inform C of the termination of this agreement in writing no later than 30 days prior to the termination.

Then, B must report the termination of this contract to A, along with all relevant documents.

(1) When a dispute arises between the Parties due to the difference in the interpretation of this Agreement, it shall be resolved through mutual agreement of the parties. If conciliation fails, B and C shall accept A's interpretation.

(2) If a conflict arises between the Parties due to a difference in meaning between the Korean and the English versions of this Agreement, the Korean version shall prevail.

Policy on Research Incentives for Publications and Awards by Faculty

1. In order to encourage faculty for publication of quality papers in reputed journals and their participation in various research activities, it has been decided to reward them suitably and formalize the provision of Incentives in a systematic way. Accordingly, the following procedure is to be adopted for providing Research Incentives to faculty members.
 - (a) All the faculty will submit a copy of the publication for incentive by filling a proforma and letter addressed to Registrar through Rector.
 - (b) Book published / Book chapter will be given separate incentive.
 - (c) 100% of Research incentive will be given to Sole Author of the Publication.
 - (d) 50% of Research incentive will be given to First Author (Faculty & Full Time Research Scholars) of the Publication and remaining 50% of Amount will be equally distributed to co-authors.
 - (e) Publication through conference participation sponsored by University will not be considered for incentive.
 - (f) Special incentives will be given for awards, session chair, board member etc.
