The Acting Registrar informed the members about relinquishment from the post of Chancellor of VFSTR by Prof. K. Ramamurthi Naidu after pleasant and successful nine years of service. The Chancellor said that the Chairman graciously approved his request for relinquishment from the post of Chancellor.

V. Any other points with the permission of the Chair:

1. Welcoming the new incumbent by the members of Board of Management.

The Chancellor mentioned that he knew the new VC 12 years back and he was very dynamic that he guided 33 scholars and published good number of papers.
