

of academic year 2022-23 II semester and approved the DAAC proposed splitting of
questions into a, b, c ... parts following Blooms levels instead of giving a single
question

- The members had a discussion on the formative and summative results of academic year 2022-23 II semester. The chairperson presented the correlation between formative and summative results, and the members discussed ways to reduce the number of Rgrades and I-grades.
- Dr. Vijayalakshmi Venkatesan, Scientist 'G', National Institute of Nutrition, Hyderabad suggested to conduct more practice sessions to R and I grade students.
- Prof. G. Sathya Narayana, Department of Biotechnology, IIT Madras suggested to organize to more guest lectures with industry personnel to improve technical skills of students.
- The committee members reviewed the DAAC proposed list of NPTEL courses and approved.

Based on the suggestions given by the members, the Chairperson of BoS told that, those fruitful suggestions would be incorporated appropriately in the curriculum of the regulation R22 and this will be recommended to the Academic Council of VFSTR for the approval.
