

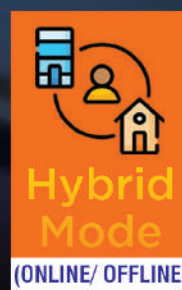

## About Conference:

Access to justice stands as a fundamental pillar of democratic societies and is enshrined in the Indian Constitution under Articles 14, 21, 22(1), and 39A, which mandate equal justice and free legal aid for all citizens, particularly the marginalized sections of society. Despite significant progress through the Legal Services Authorities Act, 1987, and the establishment of the National Legal Services Authority (NALSA) and State Legal Services Authorities, substantial challenges persist in ensuring equitable access to justice for India's diverse population.

While NALSA has facilitated the resolution of over one crore cases annually through Lok Adalats and conducted extensive legal awareness campaigns studies indicate that only small section of all litigants in India is actually receiving the services through free legal aid clinics, pointing to significant demographic disparities in access to justice.

This International Conference on **"Legal Aid and Access to Justice in the Era of AI and Technology"** envisions creating a transformative platform that brings together legal scholars, academicians, policymakers, practitioners, technology innovators, and civil society representatives to review and reimagine justice delivery for the 21st century in the era of Artificial Intelligence and technology. This conference aims to promote evidence-based discussions, share best practices, and develop actionable strategies that ensure justice is not merely a theoretical ideal but a tangible reality for all citizens, especially those facing socio-economic, geographical, and technological barriers.

- Full paper should be between 4000-6000 words
- Reference should be in 20th Harvard-Blue Book format Citation Style
- It must be typed in Times New Roman, Font Size 12 on A4 size paper with 1 inch margin on all sides and 1.5 - line spacing using MS Word
- Full paper should be submitted on or before October 25, 2025.
- All submissions are subject to Plagiarism check.
