
Minutes of Board of Studies Meeting

1. To Discuss and finalize the curriculum structure and detailed syllabus BA.LLB(Hons.) & BBA.LLB(Hons.) programmes.
2. Introduction/revision of Courses and recommended to Academic Council:
 - 2.1 To approve the replacement the existing criminal laws (Indian Penal Code, Code of Criminal Procedure, Law of Evidence) with the new criminal laws (Bharatiya Nyaya Sanhita, Bharatiya Nagarik Suraksha Sanhita, and Bharatiya Sakshya Adhiniyam)
 - 2.2 To introduce Mediation (With Conciliation) as per the directions of Bar Council of India.

Chairperson Prof. (Dr.) Chitrapu Kama Raju, Director, Vignan Institute of Law, VFSTR opened the meeting by welcoming and introducing the external members, invitees to the internal members. Chairperson presented about the *NEP 2020 Compliant Regulation - R22* which emphasis on creating *learning centric* (continuous learning and continuous assessment model).

The following points were discussed in the BoS meeting:

1. Regulation R22, Curriculum structure with credits, credits distribution, Assessment methods (Formative & Summative), Grading Schemes, Honor/Optional courses.
2. Integration of New Criminal Laws into existing curriculum.
3. Introduction of Mediation (with Conciliation) Course.
4. Resource material and teaching methodology for new criminal laws were discussed.
5. Involve experts for teaching Mediation Courses
6. Strengthen Legal Aid clinics and establish mediation clinic as per Mediation Act, 2023.
7. Introduce courses related to Law and Technology, Interdisciplinary courses in management, pharmacy, agriculture, Law and Journalism etc.
8. Offer certification/ PG Diploma courses in Air and Space Laws.
9. Need to have specialized faculty to handle the above-mentioned courses.
10. English Courses may be divided into 4 semesters but need to confirm with BCI regulations.
11. Identify UGC, NPTEL Courses relevant to curriculum.
12. The curriculum should inculcate teaching methodologies to prepare the students to work as in house legal counsels.

The following resolutions made after the discussion:

1. BoS Members approved the Integration of New Criminal Laws into existing curriculum.
2. BoS Members advised to include Mediation (with Conciliation) Course in 10th semester.
3. Total average percentage of syllabus revised was 10% compared to previous curriculum

Based on the feedback from various stakeholders and suggestions given by the members, the Chairperson of BoS told that, those fruitful suggestions would be incorporated appropriately in the curriculum and syllabi of the regulation R22 and this will be recommended to the Academic Council of VFSTR for the approval.

There being no further points for discussion, the Chairperson thanks all the external, internal members and announced that the meeting was adjourned.
