

Chairperson Dr. Vijaya Ramu Dirisala, Professor and School Dean, School of Biotechnology and Pharmaceutical Sciences, VFSTR opened the meeting by welcoming and introducing the external members, invitees to the internal members.

The following points were discussed in the BoS meeting:

1. A 5-month internship to B.Pharm. students.
2. Division of practical courses of M.Pharm (Pharmaceutics).
3. Internal and External examination patterns for M.Pharm. (Pharmaceutics).
4. Program Outcomes for M.Pharm. (Pharmaceutics).
5. Promoting M.Pharm Students towards self-paced learning
6. Result analysis of B.Pharm. odd semesters in AY 2024-25.
7. B.Pharm. and M.Pharm. courses mapping to SDGs.
8. The Credit Structure for Pharm.D Program

The following resolutions made after the discussion:

1. The BoS Members approved the 5-month internship to B.Pharm. students during their VII and VIII semester course work duration without affecting the conductance of required credit hours as required by the PCI.
2. It was proposed to divide that one practical course (Pharmaceutics Practical – I) into three courses in 1st semester and the one practical course (Pharmaceutics Practical – II) into four courses in 2nd semester of M.Pharm. after discussing the pros and cons and upon suggestion of the external expert, the BoS members approved that the practical course is divided into only three courses in both the semesters to maintain uniformity and ease of conductance. The revised structure of the practical courses is attached in **Appendix – I**.
3. The BoS Members approved the internal and external examination patterns for theory and practical courses of the M.Pharm. program. The approved examination patterns are attached in **Appendix – II**.
4. The BoS Members approved to adopt the Program Outcomes for the Post Graduate programs in Pharmacy given by the NBA. It was suggested to add two more POs specifically to the Pharmaceutics specialization.
5. It is recommended that, M.Pharm. Students may also opt for self-paced learning and acquiring credits, if the courses are offered by NPTEL.
6. The results of the I, III, V and VII semesters of B.Pharm in AY 2024-25 were discussed. The BoS members suggested the Department to take measures to improve the pass percentage especially for the I year students.
7. It was discussed and approved the mapping of the B.Pharm. and M.Pharm. courses with the SDGs. Further, a Value Added Course on “Professional Ethics” so as to map with the SDG-5 which was not mapped with the regular courses.
8. The Credit Structure for Pharm.D Program to be followed as per the norms of VFSTR
