


The Chairperson welcomed the members to the meeting. The BoS Secretary then requested all members to observe a moment of silence in tribute to the sudden demise of Dr. G. Seetharamanjaneyulu, a respected BoS member. Following this, the Secretary introduced the new BoS members and presented all agenda-related documents to the Board. The Dean of SLM expressed heartfelt gratitude to the new members for their willingness to contribute their valuable expertise in designing and developing the R25 MBA and BBA curricula. ### **Resolutions:**

1. Dr. Parthasaradhy Ramachandran, HoD of the Department of Management Studies, inquired about the rationale for incorporating an optional course within the Core course structure. The Dean and HoD explained that this approach is necessary to avoid repetition of subjects students have already studied in previous BBA and other programs. Dr. Ramachandran added that this practice is essential to provide students with advanced knowledge.
2. All members expressed their satisfaction with the MBA and BBA R25 Regulations, course structure, and course content. However, they emphasized the need to establish Memorandums of Understanding (MoUs) with hospitals concerning the Hospital Management specializations, as noted in point seven of the BoS minutes from the meeting held on 14-02-2025. The Chairperson informed the members that this matter is currently in progress and assured that the MoUs will be finalized before the next BoS meeting.
3. Dr. R. Kasilingam, Professor at Pondicherry University, recommended revising the proposed B.Com course structure. The members concurred with his suggestion and proposed that the revised structure be finalized with the guidance and support of Dr. R. Kasilingam, Dr. S. Saritha (Head of the MBA Department), Dr. K. Kalpana (Dean, SLM), Dr. K. Phani Kumar (Deputy Head of Department), and the faculty from the off-campus center. The team is also responsible for keeping the members informed of the revision's progress to enable smooth approval.

**Resolution:**

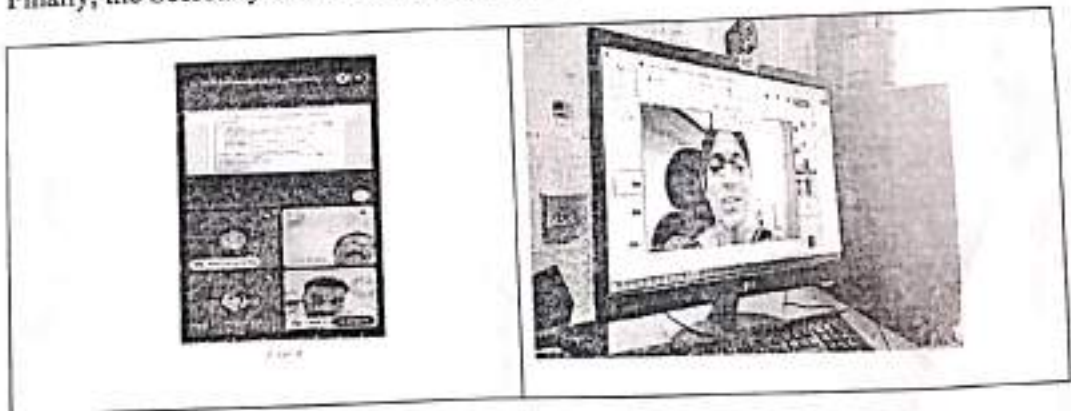

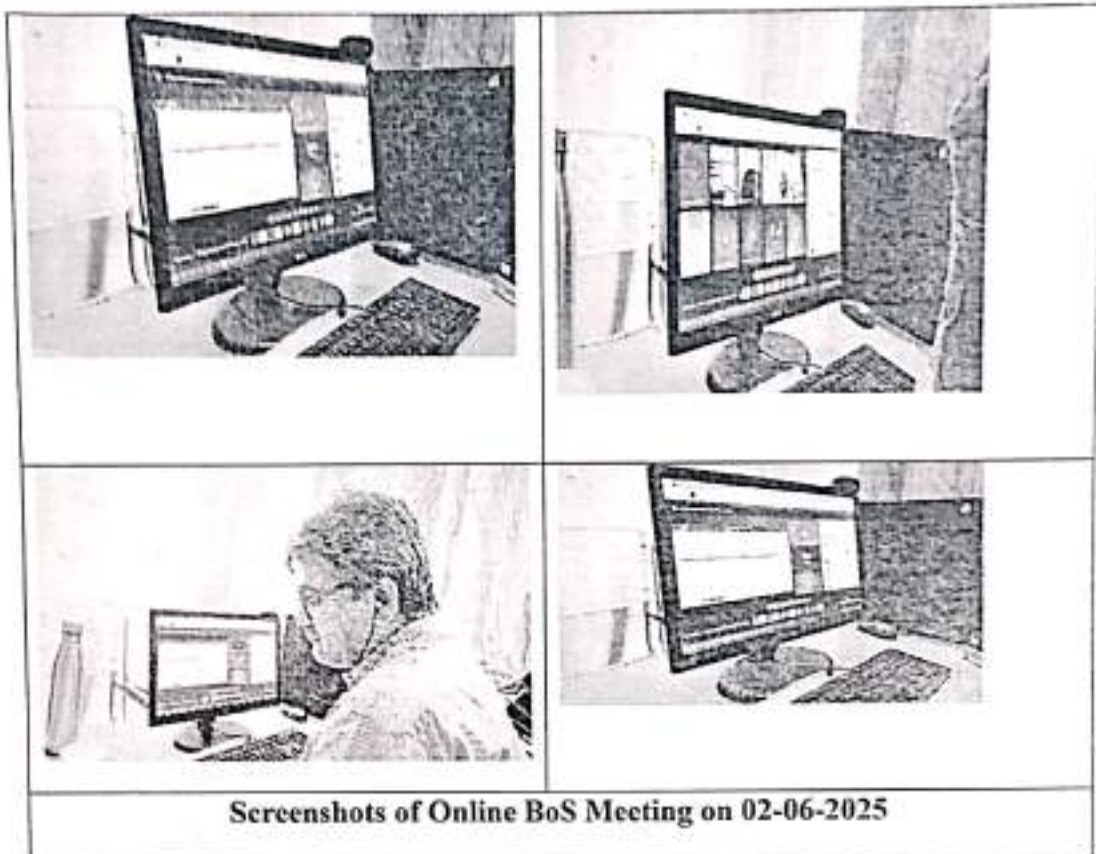
**VI. Any other points with the permission of the Chair.**

Dr. K. Naveen and Dr. P. Veera Swamy and other experts in the Hospitality and Agriculture Business industries respectively, suggested that integrating strategic Hospitality and Tourism courses into the MBA curriculum would be a valuable addition, enhancing the quality of the Management program. The Head of Department responded that this suggestion will be considered during the formulation of the next regulations.
